



Rate of Change 2012 / 2013 (%)





Equipment & Real-estate Leasing: New Business in billions of euro








More than Half of Outside Financed Investments is realized through Leasing





Breakdown by Asset Type of Leasing Business










Share of Equipment Investment in GDP in %

Rate of Investment 1995 – 2012


in % of Net Domestic Product


