




Investment of the Leasing Industry in billions of euro








1.05 Share of Leasing of Outside Financed Investments

More than Half of Outside Financed Investments is realized through Leasing



Breakdown by Asset Type of Leasing Business





Breakdown by Customer Type of Leasing Business






